

POLICY

Special Exam Accommodation

- a.** Applicants with disabilities may request special accommodation(s) to write the ASET Ethics Exam, ASET Technical Exam or the NPPE. Applicants must request special accommodation(s) at the time of application and at least seven weeks prior to the exam registration deadline date.
 - i.** Documented evidence of the applicant's disability must be submitted to ASET before a special accommodation request will be granted (e.g., a formal detailed diagnosis of the specific disability from an appropriate professional and supporting documentation citing the need for exam accommodation(s) and what accommodation(s) the applicant has received in the past).
 - ii.** ASET will review the applicant's request for accommodation(s) to determine if the request can be supported. Depending on the applicant's needs, ASET may modify exam administration conditions, including exam setting, exam presentation, or the addition of individuals to the exam (e.g., readers, scribes). Each request will be reviewed on a case-by-case basis.
 - iii.** ASET will cover the costs of approved special accommodations for the first attempt of the ASET Ethics Exam, ASET Technical Exam and the NPPE.
 - iv.** If the applicant fails the first attempt(s), the applicant will be responsible for the special accommodation costs associated with any further exam attempts. Applicants must pay all associated fees at the time of application and/or at least seven weeks prior to the exam registration deadline date.
- b.** Internationally trained applicants who may need more than the allotted time when writing the ASET Ethics Exam and/or the ASET Technical Exam, may request additional time for writing the exam by completing and submitting this form to ASET. Applicants must request special accommodation(s) at the time of application and at least seven weeks prior to the exam registration deadline date.
 - i.** Applicants must submit the results of the English language competency proficiency to ASET before this special accommodation request will be granted.
 - ii.** ASET will review the applicant's request for accommodation(s) to determine if the request can be supported. Each request will be reviewed on a case-by-case basis.
 - iii.** ASET will cover the costs of approved special accommodations for the first attempt of the ASET Ethics Exam, ASET Technical Exam and the NPPE.
 - iv.** If the applicant fails the first attempt(s), the applicant will be responsible for the special accommodation costs associated with any further exam attempts. Applicants must pay all associated fees at the time of application and/or at least seven weeks prior to the exam registration deadline date.
